# Substance Use Disorder Services & Access on Siksika Nation

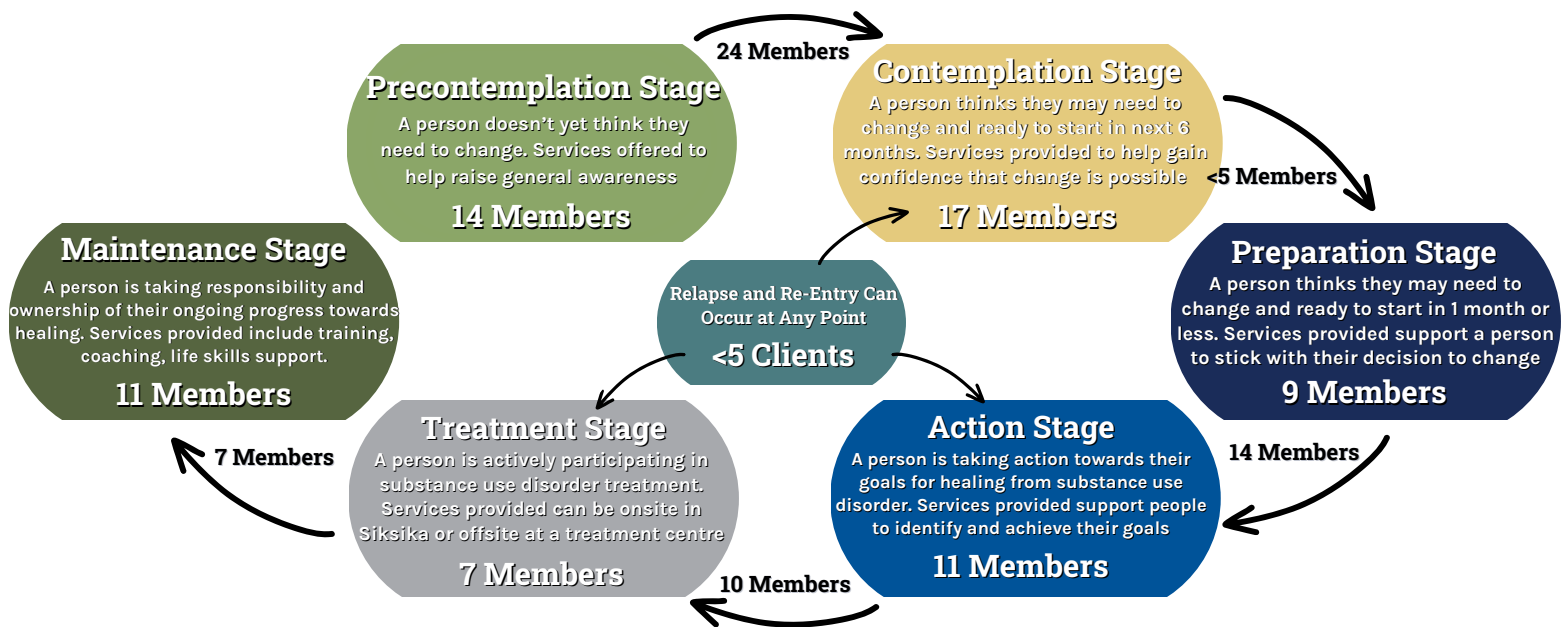
In the last year, Siksika Nation has experienced an increased number of substance use disorders and related harms. Knowledge and understanding around substance use and the addiction challenges on the Nation allow for responsive, innovative, and strategic planning to create systems that support individuals and families to achieve healthy relationships and connections, because the best protection from addiction is connection to Creator, creation, self, and others.

### ADDICTIONS SERVICES: SIKSIKA MEMBERS MOVEMENT THROUGH STAGES OF CHANGE

Siksika Health's Addictions Services follow the Stages of Change model. The path is not linear, as the journey to healing is not linear. In the month of November 2023, our current active members were moving between the following stages on their path to healing from substance use disorder:

\*please note that this includes all referral types, including court orders, etc., and not all people referred choose to become Addictions Services clients.



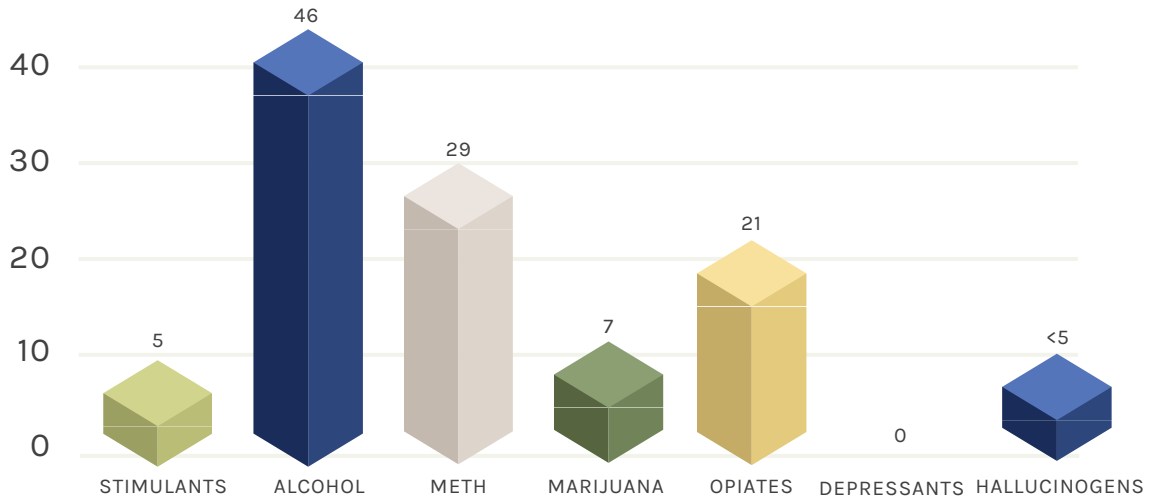
### ADDICTIONS SERVICES: SIKSIKA MEMBERS GROUP & SUPPORT SERVICES PARTICIPATION

## DRUG POISONING & PREVENTION STATISTICS

Often referred to as an “overdose”, a poisoning occurs when a toxic amount of a substance overwhelms a person’s body. Naloxone is an opioid agonist medication that can rapidly (though temporarily) reverse an opioid overdose. Siksika Nation members are strongly encouraged to have a kit on-hand, and be trained in recognition and response to overdose. 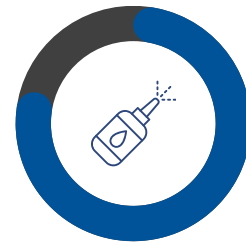

## SUBSTANCE DEPENDENCY DETOX & AGONIST THERAPIES

Detoxification (detox) is the process that occurs in the body as it eliminates toxins from long-term substance use. At Siksika Health Services, supervised detox often involves medication, medical observation, and counselling.
