POSITION SUMMARY

Siksika Health Services, in partnership with Alberta Elder Abuse Awareness Council, is seeking a Case Manager, Elder Abuse Services in Siksika, Alberta. This position reports to the Team Leader, Siksika Elders Lodge and is responsible for providing comprehensive, holistic services to older adults experiencing elder abuse in the community. Effectively engaging clients through the process of assessment, supportive counseling and referrals, the Case Manager must use best practices, follow ethical guidelines, and respect the client's uniqueness and right to self-determination while keeping in mind an individual's right to be protected.

Responsibilities include, but will not be limited to:

- Screening inquiries as to need for intervention, contact police in emergent circumstances or potential criminal matters.
- Refer non elder abuse inquiries to appropriate community resources.
- Prepare collect and maintain information for the preparation of reports and other materials.
- Report to stakeholders and funding bodies, including regular meetings with supervisor and Coordinated Community Response Group.
- Develop and maintain professional relationships with the support community; assist in the creation of and formalized partnerships.
- Maintain an accurate and confidential filing system.

MINIMUM QUALIFICATIONS:

Education and Experience:

- Diploma or degree in Social Work or a relevant equivalency of education and experience and current registration with ACSW are required.
- Three years experience in clinical screening, assessment, case management and counseling.
- Experience working with complex case management of older adults and/or domestic violence is preferred.

Knowledge, Skills and Abilities:

- Must have working knowledge of personal computers and office productivity software.
- Presentations, public relations regarding elder abuse may be required.
- Self-motivated, organized, driven, efficient, detail-oriented with exceptional prioritization skills.
- Extensive knowledge in working with First Nations community.
- Practical knowledge and understanding of Federal, Provincial and Municipal Legislation and or policies relating to older adults and elder abuse.
- Extensive knowledge in working with First Nations community, Blackfoot culture, Language, and appropriate protocols.

Requirements:

- This position requires travel throughout the community, reliable transportation, a valid class 5 driver's license and proof of auto liability insurance, is necessary.
